2016 Annual Report of the Property Committee

During 2016 we took the following initiatives to maintain the church property:

 For spring cleanup we sought volunteers again. WIGGS lawn care was re-hired to do grass mowing and trimming. Tom Robinson has kindly tended our flower beds. Chuck Saylor is contracted to do snow plowing.



- We resigned our maintenance contracts with Trago Mechanical for our new heating/cooling system. This will put the new systems on a regular maintenance schedule.
- George Himpsl continues to do multiple jobs, his time in invaluable and we are grateful! Plumbing issues, outside assistance, Rummage sale set ups, shed upkeep, did countless other tasks... and is our general "fix-it Guru!" Thanks as always George!
- Wilco Electric continues to do our major electrical work and bulb replacement 1-2 times a year with their large lift. We are investigating alternative lighting options, length of bulb life, low energy consumption and cost savings.
- We are upgrading our IT infrastructure with new Comcast cabling into the building. This should boost our Wi-Fi and connectivity abilities.

We did many capital improvements. Thanks to the Mae Haller trust we were able to: Pay off the mortgage. Replace roof, new 40 year shingles. Install a new energy star efficient HVAC system. Install and improve a new sound system, wireless, and with expanded capacities and AV screens. Install a new ADA front door with exterior push button capability. We replaced flooring throughout the fellowship hall and narthex. (Issues with clean-ability and proper adhesion are still being worked out in fellowship hall.) The narthex was painted, and soon the stairwell and trim will be as well. We installed two new drinking fountain and bottle/cup filling stations. These are ADA compatible, as well as being more eco-conscious as everyone can bring their own water bottle, instead of using plastics or cups. We had a new drive way and parking lot paved/resurfaced. We need to back fill and re-seed higher drops in spring. Keener insulating filled the entire attic with insulation, and protected the sanctuary lights. This should help our heating and AC costs, and lower electric bills. George updated all toilets with manufacturers recommended upgrades.

The following are things we need to consider for the New Year and going forward:

Replacing the 6 windows in sanctuary. These are original, take extreme weather beatings, and are beginning to rot out. The nursery needs more storage, perhaps a small entertainment center for TV/DVDs and toy storage. The narthex needs reimagined and designed, it's not neat, organized or visitor friendly— new furniture has been quoted by Benjamin Roberts LTD. George will work on replacing the basketball nets for spring use. A sound desk that incorporates all new technologies, plus the computer and AV needs. This can be crafted to match the current pews, and design of sanctuary. The steeple will need painted in the next year. George will take care of small masonry needs. A capital campaign or fundraiser may want to be considered to replace the gas (residential ranges in the kitchen) with a more heavy duty commercial grade range. This would eliminate the performance problems we encounter during dinners. They range from \$2,000-4,000.

<u>IN 2008, IN ORDER TO CUT COST, TRINITY CHANGED THE POLICY FOR PAID ADVERTISING OF OUR EVENTS</u> <u>AS NOTED BELOW:</u>

PURPOSE:

It is the purpose of this policy to ensure that Trinity Reformed Church of Christ retains enough money from its various fundraisers to allow for sufficient paid publicity and advertising without having to deplete resources from other line items or operating expenses.

A "fundraiser" shall be defined as "any event which charges for admission or participation" or "the sale of items for profit to benefit the operating or mission budget of the church." This definition shall exclude "fundraising" done by individual members of the congregation for outside groups (Boy Scouts, Brownies) or any sub-group of the church (Women's Guild).

POLICY:

Funds for publicity and advertising shall be allocated using the following guideline:

Ten percent (10%) of all profits (after expenses) shall be set aside by the Treasurer to be used for future publicity or advertising. There shall be no limit to the amount that can be "banked", but if funds should exceed what would ordinarily be deemed "prudent" for a publicity/advertising fund, an amount may be withdrawn and placed in the operating or building funds of the church.

This amount shall be decided upon and voted by the Consistory and allocated by the Treasurer.

Disbursements for advertising shall be made by the Treasurer after a cost analysis by the Chair of the fundraiser and the Pastor, or the members of consistory during a regularly scheduled business meeting, or by the Pastor and others who may hold responsibility/accountability for said fundraiser.

The Treasurer may request further details regarding the disbursement or a vote of the Consistory should he/she deem the amount to be excessive and beyond the boundaries of responsible stewardship.
